Subject: - Unauthorized holding of tournament under banner of National.


Sir,

It is understood that your Organization has asked Amateur U.P. Tug of War Association having Mr. Anil Kumar Singh resident of C-35 Gandhi Nagar, Moradabad as its President and V .P. Singh resident of 6, Shivaji Nagar Shahganj Agra 282010, as its General Secretary, for holding the 19th Senior National Tug of war Championships on 5-7th November 2011, Railway Ground Moradabad.

According to the guidelines of the Ministry only one National Level Federation for each discipline of sports can be given recognition. Since the Ministry had already given recognition to Tug of War Federation of India with Professor Gautam Kaul, President as the National Level Federation responsible for promotion of Tug of War Sport in the country, no other federation/association can organize any tournament of Tug of War as National Level Tournament. Moreover, according to the latter dated 5.7.2011 issued by the Ministry (Copy Enclosed) only recognize National Sports Federation is entitled to use the expression "of India" or "Indians" in its title and also can organize and conduct any officially recognized event, including annual national championship, for the sport.

Keeping in view the position stated above, you are directed to desist from using the word India from the letter head of your Organization and also from organizing National Level Events.

Sub: Using the expression "Of India" or "Indian" in the its title or in any athletic competition by a Sports organization.

Sir,

I am directed to refer to your letter dated 07.06.2011 regarding maushrooming of organization purporting to represent amateur golf in India and the State that only a recognized National Sports Federation is entitled to:-

- a) Use the expression "of India" or "Indian" in its title or in any athletic competition controlled by it;
- b) Represent or purport to represent itself as the National Sports Federation for the sport and represent India in the International Federation and/ or the Asian Federation for the sport;
- c) Regulate the sport in India;
- d) Select the Athletes who will represent India in international competitions for the sport and field the national team;
- e) Bid for and host, with the prior approval of the Government and others concerned, any officially recognized international amateur sport competition in India;
- f) Organise or conduct any officially recognized event, including annual national championship, for the sport.
